General Chair Items	<p>New Stay - At Home Order</p> <ol style="list-style-type: none"> 5 Bay Area Counties and City of Berkeley will be under Stay-At Home Orders: San Francisco, Santa Clara, and Contra Costa starting Sunday, Dec 6 at 10:00 PM, Marin, starting Tuesday December 8 at noon, Alameda starting, Monday December 7 at 12:01 AM, and City of Berkeley Sunday night December 6 . These orders will extend until January 4, 2021, unless extended. It was agreed that meets within those counties that have been sanctioned to run this weekend will be allowed to run. (see Motion: 2012ML) but all other sanctioned meets (intrasquad, time trials, etc.) in these counties will be cancelled and the host teams will be informed. An announcement will also be posted on the Pacific Swimming web site Sanctioned swim meets in other counties of Pacific Swimming will be allowed to go on, provided those counties or facilities do not issue Stay-at home or shutdown orders. We will discontinue sanctioning meets to be held in counties that are under Stay at Home Orders until those orders are lifted. We will continue sanctioning meets to be held in locations, facilities, and counties that remain open for such events. However, those sanctioned events will be closed down if the venue is in a location that receives Stay-at Home orders, or shut down. 		
	<p>Information from Other California LSCs</p> <ol style="list-style-type: none"> San Diego Imperial has shut down all meets and all travel for their teams. They want to keep a low profile, and not put swim practices in jeopardy. Keeping swimmers safely in the water is their first priority. California reported they had a team travel outside their area to another meet and 3 swimmers sharing a room contracted COVID19, bringing it back, so the whole team is presently shut down In Pacific the counties have not shut down the pools so far, (the governor has emphasized the importance of outdoors exercise to combat depression and other mental health issues) Mark Taliaferro reported that Santa Clara County made a definitive statement that pools may stay open
