<b>Officer's Reports</b>			
<b>Chair</b>	<p>David Cottam:</p> <ol style="list-style-type: none"> <li>1. Most Clubs can now practice, and some have competed in intra-squad, dual, and/or tri meets. However, there are a few Clubs still not in the water, and we have lost a few Clubs. We are hoping to have everything open on June 15.</li> <li>2. Rules and Regulations updates - the BOD has passed several sections to be brought up to the HOD for a vote tonight. The goal is to have the rest of the Rules and Regulations ready to be presented to the HOD in October</li> <li>3. After completion of the Rules and Regulations we will work on the revisions for the Policy and Procedures.</li> <li>4. Working on getting all Clubs Safe Sport recognized. We have just about 50% of our Clubs Safe Sport recognized at this time.</li> <li>5. At least 50% of our Clubs have at least 1 athlete representative. The athletes are working on getting 100%. The athletes have done a tremendous amount of work.</li> <li>6. Congratulations to Veronica Hernandez for receiving an award from USA Swimming for outstanding Services.</li> </ol>		
<b>Vice Chair – Program Operation</b>	<p>Leo Lin:</p> <p>No specifics, but much time in working out how to have meets during Covid, and how to maintain Covid safety during meets as there was gradual opening and change in restrictions through out the season.</p>		
<b>Vice Chair –Program Development</b>	<p>Veronica Hernandez:</p> <ol style="list-style-type: none"> <li>1. Provided further clarification about the new email communication plan.</li> <li>2. An email communication will be sent out to families of swimmers approximately once a month. The communication will be focused on what Pacific Swimming is doing, such items as celebration of the athletes, mental health resources, safe sport information, how to access MEFAP, the athlete leadership summit. It will also be used to broadcast emergency issues when they occur. It is not to be used for regular meets, and entries, etc.</li> </ol>		
<b>Treasurer</b>	<p>Mary Ruddell: Overview</p> <ol style="list-style-type: none"> <li>1. We gave out \$1 million to Clubs in grants to help them cope with the problems caused by COVID</li> <li>2. Allowed for flex membership this year</li> <li>3. We set up special rates for meets during COVID restrictions</li> <li>4. We did take losses in revenue because of the COVID restrictions.</li> <li>5. We drew on Investment Funds to provide some travel funds.</li> <li>6. We also used money from the Board Designated Funds we reserved to make up for anticipated deficits in membership fees (as planned when we raised fees by \$8 several years ago to avoid raising fees by \$2 every year to follow USA's plan).</li> </ol>

<b>Age Group</b>	<p>Kyle Kikuta – presentation by Ainsley Tambling (athlete rep to Age Group)</p> <ol style="list-style-type: none"> <li>Summers Series Championship replaces the normal season end meets (JO's, Far Westerns which will not be held this year because of COVID)</li> <li>Swimmers can submit their best times from any sanctioned meet that is held between June 18 and August 1<sup>st</sup>. The times will be collated to create the virtual Championship. For each event the swimmer with the best time in each age group (age pure groups) will be awarded winner in the virtual championship.</li> </ol>

REGISTRATION AND MEMBERSHIP</b></p> <p><b>1. CATEGORIES</b> ALL ATHLETES WHO PARTICIPATE IN PRACTICES WITH MEMBER CLUBS OR MEETS SANCTIONED BY PACIFIC SWIMMING SHALL BE REGISTERED WITH USA SWIMMING AS ATHLETE MEMBERS. ALL COACHES WHO ARE ON DECK AT PRACTICES AND/OR MEETS SHALL MEET SPECIAL TRAINING REQUIREMENTS TO QUALIFY FOR COACH MEMBERSHIP AS REQUIRED BY USA SWIMMING.
